Visiting Position teaching "Derivative Securities Analysis"

IÉSEG School of Management (EQUIS and AACSB accredited) at the Université Catholique de Lille, France, seeks to fill a visiting position in "<u>Derivative Securities Analysis</u>" (Lille Campus) for the 2015-2016 academic year (Spring semester: January to May 2016).

Job Description/ Qualifications

"Derivative Securities Analysis" is taught in in the <u>Master of Science in Investment Banking and</u> Capital Markets.

The course will cover the theory and practice of financial derivative securities and is open to candidates who demonstrate a good knowledge of both aspects. Specifically, the course will cover the characteristics (definitions, pricing, etc.) of forwards/futures, options and swap markets and products, including practical considerations on the organizations of their respective markets. Theory will be applied in the Bloomberg Financial Markets Lab, equipped with 22 Bloomberg professional terminals.

The duration of the course is 16 hours of face-to-face sessions, spread over one week (every morning from Monday to Thursday). A 2- hour exam session is planned on Friday. The course will be taught in English during the second semester of the 2015-2016 academic year (between January and May) on our Lille campus. The expected overall workload for the students is 50 hours (2 ECTS credits).

The course is open to all MSc in Investment Banking and Capital Markets students, and is not open to Exchange Program.

The successful applicant will possess strong teaching skills. Priority will be given to candidates with knowledge of Bloomberg. A commitment to research excellence is an asset, with active research portfolio. Applicants should be completely fluent in English as the course will be taught in this language. Prior knowledge of French is not required.


